



\_\_\_\_\_ I agree that if the Animal has not been sterilized prior to this Agreement, I agree to spay or neuter within six months of this signed Agreement and that this contract is not final until the spay or neuter is completed.

\_\_\_\_\_ I agree to provide appropriate food, water, and shelter, and all necessary medical care to the Animal in a timely manner. I agree to keep all vaccinations current and recommended by a veterinarian or state law; maintain flea/tick control, and ensure the Animal receives preventative medication to protect against heartworm. Any veterinary problems that may arise, including serious illnesses requiring emergency care or surgery, is my responsibility and I am responsible for all related costs. I understand all Shelter animals are given a thorough veterinary examination, updated vaccines, fecal test, deworming, and flea treatment and are treated for any medical needs as deemed necessary by the City's veterinarian. To the best of the City's knowledge, it is giving me a healthy Animal unless otherwise noted.

\_\_\_\_\_ I agree to provide obedience training for the Animal at my cost if any behavioral issues arise. I understand that Shelter animals have obedience/behavioral issues, including, but not limited to, biting, destruction, escapism, fearfulness, and dominance, that might lead to abandonment of the Animal. I agree to contact the City and/or the Commission for recommendations in resolving any issues as an effort to maintain custody of the adopted Animal. The City makes no warranty as to the temperament or physical condition of the Animal. The Animal is being adopted as is. All warranties with regard to the Animal, including any implied warranty or merchantability and fitness for a particular purpose, where they are applicable, are hereby specifically disclaimed.

\_\_\_\_\_ I agree that the Animal will always be wearing an identification tag or will be microchipped with my current contact information, including, but not limited to, name, address, telephone number, and alternate contact information. If the Animal will reside in Norris, I agree to register with the City by either providing the microchip information or obtaining a lifetime license from the City.

\_\_\_\_\_ I understand that this adoption is a lifetime commitment to the Animal, and I will do everything within my power to care for the Animal to ensure its optimum health, safety, and happiness. I agree that if I am unable to care for the Animal for its entire lifetime, I will contact the City. I understand that the City can only take back the Animal if the City has the resources and capability to do so and that it can take up to **14 days** to secure a foster home and I will provide safe and loving care of the Animal until it is returned. *See Norris City Code, Chapter 2, Dogs and Cats, § 1-216(3), Adoptions*

\_\_\_\_\_ I agree that I may not euthanize the Animal except in the case of the Animal's terminal illness or injury, or old age, accompanied by pain and suffering and in that case, euthanasia must be performed by a licensed veterinarian.

\_\_\_\_\_ I hereby release the City from any and all liability for personal injury, property damage, legal fees, or veterinary care, or any other expense or liability incurred by me as a result of this adoption. I agree to indemnify the City from any and all such claims and to pay, without limitation, any costs related to such injury, damage, liability, including, in the case of litigation, any attorney's fees incurred by the City in its defense.

\_\_\_\_\_ In the event that I do not comply with the terms of this Agreement, or the Animal is abused or neglected, the City holds the right to recover the Animal from me upon demand, and the Animal will be immediately

surrendered. Without the City waiving any of its rights under this Agreement, if I do not surrender the Animal, I will owe the City, including, but not limited to, any and all legal fees, expenses, veterinary costs, and reasonable liquidated damages associated with enforcement of this Agreement and recovery of the Animal.

\_\_\_\_\_ This Agreement (including the attached Voluntary Release/Waiver of Liability) is the entire Agreement between the Parties and supersedes any prior understandings between the Parties with respect to the subject matter of this Agreement. No modification of this Agreement will be valid unless in writing duly signed by both Parties. This Agreement is binding upon the Parties, their heirs, assigns, successors, personal representatives or executors.

**ADOPTER'S VOLUNTARY RELEASE/WAIVER OF LIABILITY**

This Voluntary Release/Waiver of Liability (Release) is made and entered into between the undersigned and the City of Norris, Tennessee, effective as of the below-indicated date. The undersigned desires to adopt an animal from the City, and hereby represents, acknowledges, and agrees to the following:

1. I, \_\_\_\_\_, acknowledge that, due to the unpredictable nature of animals, certain risks and dangers may occur while caring for an animal, including, but not limited to, risks of injury to person and property, and that I have voluntarily agreed to make the adoption contemplated herein with full knowledge of such risks and hereby voluntarily assume all such risks.
2. I agree that I will not make any claims against, sue or attach any property of the City, its directors, officers, agents, employees and/or volunteers for any injury or damage caused by the animal adopted from the City.
3. I hereby voluntarily release, discharge, waive and relinquish any and all actions or causes of action from personal injury, property damage or wrongful death occurring to me or third parties as a result of any action or activity of the animal being adopted by me from the City. It is my intention by this instrument to exempt and relieve the City from ALL liability for personal injury, property damage, or wrongful death caused by negligence or otherwise.
4. I hereby agree to hold the City and its directors, officers, agents, employees, and/or volunteers harmless and indemnify them from and against any liability, claims, judgments, or expenses I may incur arising out of my adoption of the Animal from the City.
5. I HAVE CAREFULLY READ THE FOREGOING, AND I UNDERSTAND THAT TOGETHER THEY CONSTITUTE A DISCLAIMER OF LIABILITY BY CHARITY AND A RELEASE OF ALL THE CLAIMS BY ME. I UNDERSTAND THAT I ASSUME ALL RISKS INHERENT IN MY DECISION TO ADOPT AN ANIMAL FROM THE CITY AND ANY RELATED ACTIVITIES. I VOLUNTARY SIGN BELOW TO EVIDENCE MY ACCEPTANCE OF THE ABOVE PROVISIONS.
6. If any portion of this Release is held invalid, it is agreed that the balance hereof shall continue in full legal force and effect.
7. This Release is governed by the laws of the State of Tennessee applicable to agreements entered into and fully performed therein.
